

Terms and Conditions of Offsite Games

§ 1. General provisions

1. These Terms and Conditions set out the rules applicable to *Laser Tag* Offsite Games organised by the Organiser.
2. All persons taking part in the *Laser Tag* game are required to read the Terms and Conditions.
3. The organiser of the event is LASER TAG OLIVIER ŚMIGIELSKI.
4. The Ordering Party is the entity providing the venue, including the game area. The Ordering Party shall prepare the game area in accordance with the guidelines described in these Terms and Conditions and select the game participants. The Ordering Party may be one person, several persons, some Participants or all Participants. Any issues relating to the rules of use of the game area are regulated by agreement between the Participants and the Ordering Party.
5. The Organiser shall not be responsible for the preparation of the game area and shall not be responsible for the selection of participants.
6. The Terms and Conditions shall apply to all Laser Tag games organised by the Organiser unless the parties have expressly agreed otherwise.
7. Persons present in and around the game area are required to behave in a manner that does not endanger other persons on the premises.
8. No alcohol, tobacco or drugs are allowed during the games.
9. The Organiser shall not be responsible for the belongings (e.g. mobile phones, documents, clothing) of the Participants.
10. Playing times, prices and booking rules are set out separately.
11. Equipment, in particular weapons, may not be taken outside the game area and the check-in area.

§ 2. Participants

1. Only the following persons may participate in the game:
 - 1) adults,
 - 2) 15 years old or older with the consent of a parent or a legal guardian,
 - 3) under 15 but over 7 years old accompanied by an adult guardian, with their written consent.
2. Participants and other persons under 18 years old are not under the supervision of the Organiser.

For the cases referred to in section 1 points 2 and 3, a guardian shall be responsible for the minor Participant.
3. The game is open only to persons who are sober and not under the influence of intoxicants.
4. Pregnant women should not take part in the game.

5. Persons suffering from medical conditions which, in the event of physical effort, may endanger their health or life, are not allowed to take part in the game.
6. Participants wearing jewellery, spectacles and other similar items are required to remove or secure them in such a way that they do not endanger their health and safety or the health and safety of other Participants.
7. Participants shall choose footwear and clothing suitable for participation in the game, in particular that is resistant to dirt or contact with rough and hard objects.

§ 3. Gameplay

1. The Organiser shall ensure that the equipment works properly and shall instruct Participants on the main rules of the game and how the equipment works. The Ordering Party shall provide and prepare the game area.
2. Participants are instructed on the main rules of the game and on the operation of the equipment before the start of the game.
3. Any observed defects or faults in the equipment should be reported by Participants to the staff before the start of the game or as soon as they are discovered.
4. Participants are aware that the equipment's edges are sharp and some of its parts protrude, hence they are required to take special care when handling it.
5. Any damage to the equipment caused during the game shall be the responsibility of the player, unless the damage occurred during proper use of the equipment.
6. Participants are required to familiarise themselves with the game area before starting the game.
7. No drinks, food or any unnecessary objects, especially mobile phones or cameras, are allowed into the game area.
8. During the game, Participants shall behave in a spirit of *fair play*, with respect for the rules, fairness and mutual respect towards other Participants.
9. Pushing other Participants or any other physical contact is not allowed, as well as grabbing weapons belonging to other players.
10. It is not allowed to hide or remove the sensors from the head during the game or to switch off the device without the knowledge of the Organiser.
11. During the game, it is not allowed to throw or wave the equipment, or damage pieces of equipment.
12. The staff may exclude the following persons from the game:
 - 1) infringing the provisions of the Terms and Conditions;
 - 2) drunk or intoxicated.

13. An excluded person shall not be entitled to a refund of fees.

§ 4. Preparation of the game area

1. The Ordering Party shall prepare the game area in accordance with the following guidelines.
2. The Ordering Party shall clean the game area of all sharp objects and tools.
3. There shall be no dangerous holes in the game area into which a Participant could fall.
4. The areas where there is a risk of falling shall be secured so as to prevent the Participant from falling.
5. The boundaries of the game area shall be clearly demarcated. So that Participants have no doubt where the game area ends.
6. No bystanders, animals or vehicles are allowed in the game area.
7. The Ordering Party shall clear the game area of any objects that the Participant might trip over.
8. The Ordering Party shall clear the game area of all objects, machinery, etc. that could endanger the life or health of the Participants.
9. The game area shall be sufficiently illuminated to allow Participants to move around it safely. For example, the game cannot take place at dusk or at night if there is not sufficient artificial lighting across the game area.
10. The game may not take place in case of rain. Similarly, it is not advisable to play immediately after heavy rainfall, due to the slippery surface, which can pose a danger to Participants.
11. The game area should contain obstacles behind which Participants can hide, this is a necessary element of the game. These can be natural obstacles such as trees and shrubs or elements placed by the Ordering Party.
12. There is an option to order inflatable obstacles from the Organiser, but this requires a suitable area for their installation. Inflatable obstacles shall be ordered on the basis of separate provisions after the Ordering Party has provided the Organiser with photographs of the game area.

§ 5. Final provisions

1. Participation in the game shall constitute acceptance of the Terms and Conditions by the Participant.
2. The Terms and Conditions are available in Polish and English. In case of discrepancies, the Polish language version shall prevail.

3. The Organiser declares that he is insured against civil liability. The Organiser does not provide individual insurance against accidents for Participants.
4. Any damage caused by the Participant as a result of non-compliance with the Terms and Conditions will be the responsibility of the Participant.
5. Participants shall be aware that the Organiser is not responsible for the behaviour of other participants and undertake not to make any claims against the Organiser in this respect.
6. Any disputes shall be resolved by the court having jurisdiction over the Organiser's registered office, unless otherwise provided by mandatory provisions of law.
